Your blatant disregard for the safety of all the residents here is despicable. Your inaction and continued silence in this matter can only prove that you are insensitive to the safety of all the residents here and willingly put our lives in danger. I want you to immediately address this issue and explain to all the residents here what your plans are in ensuring that such incident will not happen again.

On the same note, I appeal to you again to quickly draw up a Contingency Plan for Fire and Emergencies. There are many disabled and elderly residing here who may need help to be moved to safety in the event of a disaster. If you are ignorant of how this can be accomplished, the Jabatan Bomba dan Penyelamat is the best agency to refer to for advice.

I hope you will look into these matters without delay and act responsibly before any fatality occurs.
